ABOUT THE TOTTENHAM TO ALBURY PROJECT

The Inland Rail Tottenham to Albury (T2A) project is an enhancement to 305 km of the existing North East Rail Line. This project will see tracks lowered or bridges replaced at two dozen sites to provide the height and width needed to support the running of double stacked freight trains along the existing rail corridor.

BENALLA PRECINCT

As part of the project, we are proposing to build a new and higher bridge to the right of the current one which is north west when looking at the station from McKellar Street. This is because the current bridge doesn't provide the height or width needed to support taller trains to pass safely underneath.

Building a new bridge adjacent to the existing structure will minimise the impacts on station access during construction until we tie the new structure into the existing road alignment.

WHAT'S BEEN HAPPENING?

We met with commuters and neighbours towards the end of 2018 to present our early design thinking and seek feedback on the bridge replacement proposal.

During our on-ground engagement and from feedback received via email, letters and our online Community Feedback Panel, you've told us:

- poor sight lines make turning right from the western off-ramp onto Mackellar Street dangerous
- building 'off-line' is preferred to minimise traffic disruption.

In response to the feedback received, we are:

- exploring the possibility of two one-way ramps one to the station and one from the station – to minimise conflicts for vehicles
- reaffirming the 'off-line' bridge replacement alignment.


ARTC has also confirmed the maintenance access off-ramp may no longer be required.

There is also opportunity to give us your thoughts around landscaping around the new structure.

We will be looking to incorporate elements important to the community as we work to finalise our design solution.
