
#### Planning Approval Process

- Australian Rail Track Corporation (ARTC) is the proponent for the application which was lodged with DPE on 12 June 2018.
- The **Illabo to Stockinbingal** proposal is State significant infrastructure (SSI) as it meets the requirements of the *SRD SEPP 2011* development of rail infrastructure by ARTC that has a capital investment value of more than \$50 million.
- The proposal will be assessed under Division 5.2 of the Environmental Planning and Assessment Act 1979.
- The Minister for Planning (the Hon Anthony Roberts) is the determining authority for the proposal.
- DPE issued the Secretary's Environmental Assessment Requirements (SEARs) for the proposal on 19 September 2018.

### **SEARs**

- The SEARs identify the key issues and assessment requirements for the Environmental Impact Statement (EIS).
- SEARs are prepared in consultation with and in consideration of key issues raised by public agencies and councils.



# Environmental Impact Statement

- Prepared in accordance with the SEARs and the *Environmental Planning and Assessment Regulation*  2000 and includes:
  - Detailed description of the project and project area
  - Statement of the objectives of the project, including strategic need and justification
  - Analysis of feasible alternatives and options
  - Environmental risk analysis
  - Assessment of environmental impacts
  - Measures to avoid and minimise impacts
  - Community consultation and issues raised
- The EIS will be publicly exhibited for a minimum period of 28 days during which time DPE will accept submissions.



# Response to Submissions and Preferred Infrastructure Report

- Following the EIS exhibition, the Department will request ARTC to provide a response to the issues raised in submissions from the community, councils and public agencies.
- Any changes to the project to address submissions and design refinements will be addressed in a Preferred Infrastructure Report (PIR).
- The Response to Submissions and the PIR, if required, will be made publicly available on the DPE major project's website.



#### Assessment and Determination

- Following receipt of the Response to Submissions, and a PIR where applicable, the Department will assess the proposed project.
- This assessment will take into account all issues raised in submissions as well as the Proponent's response to these.
- The assessment will focus on the expected impacts from the proposed project and any measures proposed to mitigate them.
- On completion of the assessment, DPE will make a recommendation to the Minister to either refuse or approve the proposed project.
- The Minister will then Determine the project. If approved, the approval will be based on a number of conditions that were informed by the Department's assessment and are aimed at managing impacts from the proposal.
