Inland Rail

Enhancing the North East Rail line to allow for double-stacked freight train clearance

ACTIONS FROM LAST MEETING

- 1 Expected noise levels of double-stacked freight trains, compared to single-stacked

NOISE



Field work and monitoring surveys were undertaken in January 2019 with the intent of investigating the influence of single and double stacked containers (axle-loads) on noise and vibration emissions.

The assessments found the difference is insignificant (less than 2 db).

This is consistent with guidance from ISO 3095:2013 Acoustics – Railway application – Measurement of noise emitted by railbound vehicles.


