# FREQUENTLY ASKED QUESTIONS

#### **General**

- Q. Why do Inland Rail Community Consultative Committees (CCCs) need to be renewed?
- A: The CCCs ensure representation of diverse viewpoints and provide a platform to raise community concerns to the Australian Rail Track Corporation (ARTC). At the commencement of the CCCs in Queensland, it was established that the membership would be reviewed after a period of two years. This is a chance for both ARTC and the current members to consider how the CCCs can best proceed until project approval.
- Q. Which committee is being renewed?
- A: Kagaru to Acacia Ridge and Bromelton.
- Q.What input can the Kagaru to Acacia Ridge and Bromelton Community Consultative Committee (CCC) have during the primary approvals phase?
- A: ARTC will keep Kagaru to Acacia Ridge and Bromelton CCC members informed about the primary approvals process, public display period, any supplementary information required for the primary approvals documentation, local opportunities and changes to the project. ARTC will continue to seek feedback from CCC members about their communities/organisations in relation to the project.



- Q. What will happen to the Kagaru to Acacia Ridge and Bromelton CCC after the project's primary approvals process?
- A: Following statutory approval there will be ongoing opportunities to be involved in the project. We will continue with our engagement activities where we will actively respond to individual enquiries, and host workshops with relevant community groups and individuals where required. We will also meet with key stakeholders and community groups to share information about the project in a forum setting at relevant milestones/regular intervals. At this time, subject to any conditions of approval for the project, the Kagaru to Acacia Ridge and Bromelton CCC may be replaced by a community reference group to be led by the contractor appointed to construct the enhancement work areas for the project. Membership of that group will be determined by the contractor, in accordance with any conditions.
- Q. Will the Kagaru to Acacia Ridge and Bromelton CCC Charter be updated?
- **A:** It will be at the discretion of the reformed Kagaru to Acacia Ridge and Bromelton CCC to review the existing Charter.
- Q. What is the role of ARTC at Kagaru to Acacia Ridge and Bromelton CCC meetings?

#### A: ARTC will:

- provide briefings and updates on the Kagaru to Acacia Ridge and Bromelton project
- discuss and provide information on negotiable aspects of the project
- ▶ take on board feedback from the CCC.
- Q. Will observers be able to attend future meetings?
- A: Yes (pending COVID-19 government regulations).
- Q. When and where will future meetings be held?
- **A:** The CCC will meet at an appropriate place and time as notified to CCC members by the Chair. It is expected the CCC will meet quarterly (every 12 weeks) on dates and places set out in advance.

# **Nomination process**

#### Q. Who can apply for a position on the Kagaru to Acacia Ridge and Bromelton CCC?

A: You can apply to join the CCC as a representative of a community interest group, business or as an individual resident.

## Q. Where are you advertising the Kagaru to Acacia Ridge and Bromelton CCC nomination process?

A: The CCC nomination process will be advertised in local papers, social media and online.

### Q. Does the Chair have to reapply?

A: The existing Kagaru to Acacia Ridge and Bromelton CCC Chair has been asked to stay to provide consistency for the reformed CCC going forward.

# Q. How long will members be appointed for?

A: The appointment as a member of the Kagaru to Acacia Ridge and Bromelton CCC is for up to two years or until the project has gained statutory approval.

#### Q. What is the role of the Kagaru to Acacia Ridge and **Bromelton CCC member?**

A: Members of the CCC will:

- receive briefings and updates on the Kagaru to Acacia Ridge and Bromelton project
- discuss and provide comment or feedback on negotiable aspects of the project
- represent community views regarding local issues, impacts and benefits
- act as a conduit to provide information about the project to the broader community.

CCC members are bound by the existing Charter.

### Q. Who is going to assess the applications?

A: All nominations will be evaluated by an independent assessor.

### Q. How will nominations be assessed?

A: Membership of the Kagaru to Acacia Ridge and Bromelton CCC is on the basis of demonstrated local community connections and communication channels, or due to knowledge of disciplines related to infrastructure, as well as residence within the project area.

#### Q. Will there be interviews?

A: Phone interviews may be conducted by an independent assessor as part of the assessment process.

#### Q. When do applications close?

A: Applications close at 5pm Friday 13 November 2020.


### Q. How will those submitting a nomination form know if they have been successful/unsuccessful?
